If requested by the event management, proof of age must be provided by presenting the original valid identity card, child ID card or passport. Multiple entries within a class are not permitted. By registering, all starters acknowledge the announcement of the event in all parts. Participants under the age of 18 must have written consent from their legal guardian (see Appendix B).

If you do not participate, the entry fee will be forfeited. If the transfer is not made on time (payment received by April 17, 2024 at the latest), start is excluded.

**Performance classes** See class division/form specifications (see Appendix A).  
The age group rule applies - the year of birth always counts -> not age!

**Schedule:** Hall opening: 8:30 a.m  
Referee meeting: 9:00 a.m  
Welcome: 9:30 a.m  
Tests: 9:45 a.m  
Competitions start: 10:00 a.m  
Tournament end (expected) 6:30 p.m

**Modus:** **Poomsae individual, pair, family and team competitions PC 1 + PC 2**  
All participants present 2 shapes in 2 rounds (1 shape per round).  
There are 2 different forms to present.

**Poomsae individual, pair, family and team competitions PC 3**  
All participants present 2 shapes in 2 rounds (1 shape per round).  
With the LK 3, two identical shapes can also be present.

**Poomsae pair and team competitions**  
The composition is gender-neutral and can be put together as desired.  
The LK is always chosen according to the highest-graded athlete  
(example: 1 Dan + 7th Kup -> LK 1).

### **Poomsae Family**

Two athletes from  $\geq 2$  generations (e.g. parent & child).  
The composition can be gender-neutral. There are no age requirements at Poomsae Family.  
The LK is always chosen according to the highest-graded athlete (example: 1 Dan + 9th Kup -> LK 1).

### **Poomsae Para**

The degree of impairment must be proven by a medical certificate or a classification in accordance with the applicable WOP Para of the DTU. Athletes who start in the para field are not admitted to other starting classes.  
All participants present 2, preferably different, forms in 2 rounds.  
(1 shape per round). Two identical shapes can also be present.

### **Freestyle**

Execution according to the current WO Freestyle Basic of the NWTU.  
The music must be sent to the event management in mp3 format no later than 1 week after the registration deadline. The music file must be clearly named with the last name + first name of the starter. Sending the  
Music files to: [m.sand@nwtu.de](mailto:m.sand@nwtu.de). **Without music -> no start possible!**  
All participants present 1 round.

The size of all competition/mat areas is generally 8 x 8 m.  
For freestyle pairs and teams, the size is approx. 9 x 8 m.

### **Rating:**

The currently valid competition regulations of the DTU / NWTU as well as the regulations for sports traffic technology with the advertised changes apply. The composition of the jury can vary after a round has been completed.

In the event of a tie, the higher presentation score decides. If this rating is the same, the knockout rating is added. If there is still a tie, a play-off will be carried out. The form is determined by the event management.

### **Schedule:**

A preliminary schedule and a preliminary list of participants will be published on the Internet at [www.nwtu.de](http://www.nwtu.de) shortly after the registration deadline.

The times stated in the schedule are provisional and can be changed by the event management, even without giving reasons. If participants are not present when the starting class is rescheduled, there is no entitlement to a subsequent start or to a refund of the entry fees.



**Award ceremony:** Modalities for the award ceremony will be announced before the start of the event.  
There will be no forwarding of medals, trophies or certificates.

**Honorary gifts:** All participants receive a certificate.  
Medals or trophies for places 1 to 3.  
Participants from 4th place receive a participant plaque.  
Club ranking: Honorary gifts for places 1 to 5.  
The points key 6 - 3 - 1 applies.  
There is 1 point for first places without a fight.

**Data protection:** Declaration of consent in accordance with Section 4a of the Federal Data Protection Act: Every athlete/supervisor participating in the event agrees to the collection, processing and use of personal data within the scope of the NWTU's intended purpose. Consent to the collection, processing and use of personal data can be revoked at any time by email at [dsb@nwtu.de](mailto:dsb@nwtu.de) or in another written form. The data will then be deleted or blocked immediately, provided there are no legal retention periods to the contrary.

**Anti-Doping:** All participants expressly recognize the NADA Code in its currently valid version and, by registering and participating in the event, agree to the application of the NADA anti-doping guidelines. The anti-doping law is observed and adhered to.

**Image recordings:** All participants, their legal guardians or supervisors acknowledge that all film and photo recordings taken as part of the event are released for publication on the NWTU homepage and social media platforms. Further information can be found in Appendix D. For underage participants (< 16 years of age), Appendix C must be completed, carried and presented upon request.

**Liability:** All participants take part in the event at their own risk and declare by registering that they are in perfect health. By reporting, the participants or their legal guardians expressly agree to the exclusion of liability.
